example:

Example 1. Customer paid till 7th monthly amount & not paid further.

Total received: $2000 \times 7 = 14000/-$

Amount forfeit: Rs.6000/- Amount refund: Rs 8000/-

Example 2. Customer paid till 3rd monthly amount.

Total received: $2000 \times 3 = 6000/-$

Amount forfeit: Rs.6000/- Amount refund: NILL

If any defaulter wants to revive his/her product then Rs. 1000/- will have to be paid as revival charges.

Processing & service charges @1% i.e. Rs200/- & VAT @1% & Service Tax on service charges shall be paid by the customer at the time of delivery. ”
